(photocopies will not be accepted)

Foreign Student/Graduate Veterinarians - If enrolled in, or a graduate of a foreign veterinary school not accredited by the AVMA, please submit an official verification of completion or of current enrollment completing step#3 examination (BCSE) in the Educational Commission for Foreign Veterinary Graduates (ECFVG) program or the Program for the Assessment of Veterinary Education Equivalence (PAVE) program with this application.

NAVLE Testing Window Requested – WV does not have a limit of how many times a NAVLE candidate may not sit for the NAVLE exam.
