CONSENT AGREEMENT AND ORDER

The West Virginia Board of Veterinary Medicine ("Board") has conducted an investigation of allegations that certain conduct by Respondent, Jean Loonam, DVM ("Dr. Loonam"), may constitute violations of the Board's governing statutes, W. Va. Code §§ 30-10-1 et seq., and the rules promulgated thereunder, W. Va. Code R. §§ 26-1-1 et seq. Having made a finding of probable cause to pursue disciplinary action, the Board gave Dr. Loonam written notice of the allegations against her and the opportunity to request an administrative hearing under the rules of the Board and the laws of this State. Rather than proceeding to an administrative hearing, the parties have agreed to the entry of this Consent Agreement and Order to resolve and dispose of this matter.

FINDINGS OF FACT

The Board adopts the following factual findings:

1. Dr. Loonam is a licensee of the Board, holding License No. 55-2016, and at all times relevant hereto, held an active license issued by the Board.

- 2. Dr. Loonam also holds a license with the Virginia Board of Veterinary Medicine (License No. 0301-200211).
- 3. On or about November 7, 2018, Dr. Loonam completed an online application form in order to renew her license with this Board.
- 4. As part of that online application form, Dr. Loonam was asked the following question: "Has your license in any state/jurisdiction or your authority as a veterinarian been disciplined or restricted by any authority since your last annual license renewal was submitted to this board?" If answering "yes," the form instructed Dr. Loonam to "provide details and/or upload documentation to explain each question below that you responded to with a 'yes' answer. You must upload a file with pertinent details."
- 5. Dr. Loonam responded to this question with a "No" answer and, therefore, did not provide any details or upload any documentation.
- 6. At the end of the online renewal application form, Dr. Loonam certified that "I have personally completed this renewal form, and that I have read and understand all questions and statements on this renewal form. I further declare under penalty of perjury that the foregoing submissions and answers are true and correct."
- 7. Dr. Loonam's online renewal application was processed and her license was renewed effective November 7, 2018.
- 8. On or about November 20, 2018, the Board received information from AAVSB that Dr. Loonam had been disciplined by the Virginia Board of Veterinary Medicine in March 2018. More particularly, Dr. Loonam agreed to a "Consent Order" entered by the Virginia Board of Veterinary Medicine on March 6, 2018, wherein she admitted to a finding that, "during her employment at Kingdom Animal Hospital, Clear Brook, Virginia, in or about 2015, she allowed

an unlicensed staff person to access Schedule II-V drugs and fill the prescriptions for those drugs" in violation of Virginia statutes and regulations. Dr. Loonam was reprimanded and assessed a monetary penalty of \$200.00 under that Order.

- 9. The aforesaid discipline by the Virginia Board of Veterinary Medicine occurred after Dr. Loonam renewed her license with this Board on January 26, 2018. Accordingly, the discipline should have been reported on the online renewal application form that Dr. Loonam submitted to this Board on November 7, 2018.
- 10. By letter dated January 10, 2019, the Board informed Dr. Loonam that it had initiated disciplinary proceedings based upon the discipline in Virginia and the apparent misrepresentations made in renewing her West Virginia license. The Board requested that Dr. Loonam provide a written response to the allegations within 30 days.
- 11. By letter to the Board dated January 15, 2019, Dr. Loonam responded that "[o]ur office manager (Melanie Lloyd) filled out the form for me online as she paid for the relicensing fee and mistakenly checked off the no box. In checking the form I did not catch the error. I did not intentionally attempt to hide the proceedings against me in the state of Virginia."
- 12. At its meeting on April 11, 2019, the Board reviewed the documentation described herein and found probable cause to believe that Dr. Loonam was earlier disciplined by the Virginia Board of Veterinary Medicine, but failed to report that discipline, and did not disclose that discipline when renewing her license on November 7, 2018 despite being expressly asked to do so, all in violation of W. Va. Code §§ 30-10-19(g)(1), (5) and W. Va. Code R. §§ 26-1-7.14, 26-1-8.1.a, and 26-1-8.1.o.

13. The Board, by majority vote at its meeting on April 11, 2019, determined there was sufficient evidence to warrant further proceedings and that further action should be taken against Dr. Loonam.

CONCLUSIONS OF LAW

- 1. As a licensee of the Board, Dr. Loonam is subject to the licensing requirements and disciplinary rules of the Board.
- 2. The Board is a state entity created and governed by W. Va. Code §§ 30-10-1 et seq., and is empowered to regulate the practice of veterinary medicine in the State of West Virginia.
- 3. In order to carry out its regulatory duties, the Board may suspend, revoke, or otherwise discipline an individual's license to practice veterinary medicine under the authority granted to it by W. Va. Code §§ 30-10-5 and 30-10-19 and W. Va. Code R. §§ 26-1-9 and 26-2-1 to 26-2-6.
- 4. In addition to any other sanction imposed, a veterinarian subject to discipline may be assessed the costs and legal fees incurred by or on behalf of the Board. W. Va. Code R. § 26-1-9.5.
- 5. Dr. Loonam was notified of the allegations against her pursuant to the rules of the Board and the laws of this State.
- 6. Dr. Loonam was disciplined by the Virginia Board of Veterinary Medicine in March 2018, which discipline should have been reported to this Board.
- 7. Dr. Loonam was required to provide complete and accurate information to the Board in the course of renewing her West Virginia license on November 7, 2018 and failed to do so.

- 8. Dr. Loonam falsely certified that she personally completed the online renewal application form submitted November 7, 2018 and that the information provided therein was true and correct.
- 9. Dr. Loonam failed to otherwise report to the Board the earlier disciplinary action by the Virginia Board of Veterinary Medicine.
- 10. The Board relied on Dr. Loonam's online renewal application form, submitted November 7, 2018, to renew her West Virginia license.
- 11. Dr. Loonam's conduct, as described herein, constitutes violations of W. Va. Code §§ 30-10-19(g)(1), (5) and W. Va. Code R. §§ 26-1-7.14, 26-1-8.1.a, and 26-1-8.1.o. Such conduct is therefore grounds for disciplinary action.

CONSENT OF LICENSEE

- I, Jean Loonam, DVM, by signing this Consent Agreement and Order, acknowledge the following:
- 1. After having had the opportunity to consult with an attorney of my choice, I sign this *Consent Agreement and Order* voluntarily, freely, without compulsion or duress, and understand that my signature has legal consequences.
- 2. No person or entity has made any promise or given any inducement whatsoever to encourage me to make this settlement other than as set forth in this document.
- 3. I am aware that I may pursue this matter through appropriate administrative and/or court proceedings. I am aware of my legal rights regarding this matter, but I have chosen to waive those rights intelligently, knowingly, and voluntarily.
- 4. I waive any defenses, including but not limited to laches, statute of limitations, and estoppel, that I may have otherwise claimed as a condition of this agreement.

- 5. I admit that my actions violated the statutes and rules of the West Virginia Board of Veterinary Medicine.
- 6. I acknowledge that the execution of this document constitutes disciplinary action by the Board and is therefore considered to be public information.

The Respondent, Jean Loonam, DVM, by affixing her signature hereto, agrees to the following Order.

ORDER

Based on the foregoing, the Board does hereby ORDER and DECREE as follows:

- 1. Dr. Loonam is hereby REPRIMANDED for her actions in this matter.
- 2. Within sixty (60) days from the date of entry of this Order, Dr. Loonam shall pay to the Board a monetary fine of Two Hundred Fifty Dollars and Zero Cents (\$250.00).
- 3. Within sixty (60) days from the date of entry of this Order, Dr. Loonam shall reimburse the Board the costs of this proceeding, including the administrative and legal expenses incurred by the Board in the investigation and disposition of this case.
- 4. Any failure to comply with all provisions in this *Consent Agreement and Order* may result in additional disciplinary action, up to and including the suspension or revocation of Dr. Loonam's license to practice veterinary medicine in the State of West Virginia.
- 5. This document is a public record as defined in West Virginia Code § 29B-1-2. The Board is bound by law and by this Agreement to report the results of all disciplinary actions, including this matter, for posting in the AAVSB Veterinary Practitioners Disciplinary Database and for posting on the Board's website.
- 6. This Consent Agreement and Order constitutes the entire agreement between the parties.
